## ● Support for the introduction of protective clothing

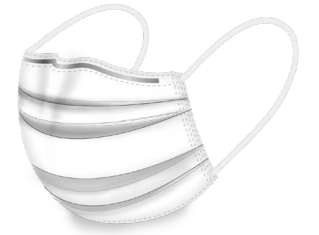
- After reviewing the nature of the work and the type of work environment, the statutory regulations, risks and so forth, we then propose the type of protective clothing that is appropriate.

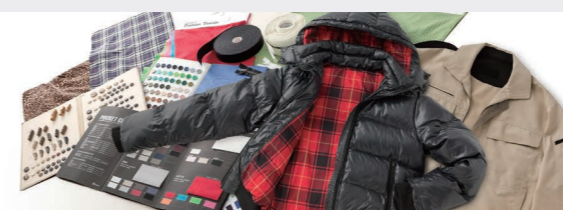

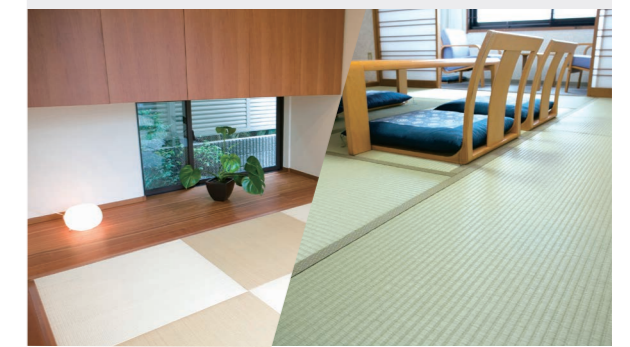
